#### ARCHITECTRUAL STANDARDS BULLETIN

Section 9.24 of the Amended and Restated Declaration of Covenants, Conditions and Restrictions for The Downs of Hillcrest (the "CCRs") states that, "[n]o signs or flags shall be displayed to the public view on any Lot without the prior written approval of the Architectural Control Committee" with certain exceptions as specified therein. Pursuant to Section 10.02 of the CCRs, the Architectural Control Committee issues this bulletin establishing the standards under which political signs may be displayed to public view on any Lot pursuant to the CCRs and the regulations set forth by the State of Texas and the City of Dallas.

Only signs advertising a candidate or measure for an election are permitted as Political Signs. Such Political Signs may only be placed on a Lot in public view on or after the ninetieth (90th) day before the date of the election to which the sign relates and must be removed from public view on or before the tenth (10th) day after that election date. Each Lot is allowed only one (1) sign for each candidate or measure.

Political Signs must comply with the following standards:

- must be ground-mounted
- may not be larger than four feet by six feet (4' x 6')
- may not contain roofing material, siding, paving material, flora or other similar building, landscaping or nonstandard decorative component
- may not be attached in any way to plant material, a light, a trailer, a vehicle or any other existing structure or object
- may not include the painting of any architectural surface
- may not contain, include or be accompanied by balloons
- may not contain, include or be accompanied by lights or any form of illumination
- may not contain, include or be accompanied by any moving elements
- may not contain, include or be accompanied by music or other sounds
- may not contain, include or be accompanied by streamers or any other driver distraction
- may not contain language, graphics or any display that would be offensive to the ordinary person
- may not violate any applicable law

Any Political Sign displayed in violation of these standards will be considered a violation of the CCRs and may be removed by the Downs Homeowners Association under Section 259.002(e) of the State of Texas Election Code.


